Each week, committees in the Texas Legislature consider specific bills related to public education. You can add your voice to advocates across the state calling for high-quality public education for every student.

With health precautions in place, most public input will occur online. You can help without missing school or work to travel to Austin. Every Monday afternoon, IDRA will help students, families, educators and community

members submit their own comments on education bills being debated by Texas lawmakers that week. #ShareYourStory

What happens during IDRA's virtual office hours?

- Get information on bills that will be heard by lawmakers that week.
- Summarize your own story and how a proposed bill would impact schools in your community.
- See how to use Texas' online public comment portal so you can share your thoughts and ideas with lawmakers.
